## Additional Information

Please tell us about any innovative packaging sustainability initiatives you have implemented during your chosen 12 month reporting period.

Throughout 2023/2024 we have continued to work with our customers and suppliers to educate them with regards to the updated Australian thresholds for our packaging formats. We are actively working towards modifying our packaging to more sustainable and recyclable materials, in-line with currently available guidelines and targets, such as the CEFLEX standard, and are actively planning for the upcoming updates within the Australian market.

We have also in the last 12 months continued developing our Bamboo Fibre MAP Tray for the Australian market, achieving a home compostability ABA certification and submitting an Alternate Fibre Submission for review so that the tray can be considered as a recyclable tray for kerbside collection.

Please tell us of any constraints you may have had during your chosen 12 month reporting period that has impacted on your packaging sustainability initiatives and Covenant obligations.

As an importer of packaging, we are somewhat limited with the availability of FDA food grade approved recycled feedstock for use as an input into the packaging sourced. This tends to be dependent on the country our packaging is sourced from, and means that as part of our Approved Supplier Program we are constantly educating, updating and working with our supplier network to develop solutions. With no realistic soft plastic collection and recycling system in place in Australia, confidence with end users, customers to move forward with APCO approved sustainable plastic structures is low and benefits of doing so are questionable, particularly with competing factors of price and functionality.

## APCO Action Plan Commitments

For each of the Packaging Sustainability Framework criteria listed below, a description is provided along with the commitments made by the organisation in their APCO Action Plan.

Criteria 1:

### Governance & Strategy:

This criteria considers actions to integrate packaging sustainability into business strategies.

- Develop a strategy that includes goals for packaging sustainability that addresses the Sustainable Packaging Guidelines (SPGs) or equivalent.
- Include a commitment to the 2025 National Packaging Targets and aim to integrate it within business processes.
- Communicate and promote packaging sustainability objectives and targets within your organisation and to external stakeholders (suppliers, final consumers, community groups etc.).

## Criteria 2:

**Design & Procurement:**

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).

- Use the Sustainable Packaging Guidelines to review our packaging to identify opportunities for improvement.
- Record the outcomes of reviews or packaging using the Sustainable Packaging Guidelines so that any team member can refer back to them in future and for auditing purposes.
- Conduct packaging reviews using the SPGs for 50% of our packaging.

## Criteria 3:

**Recycled Content:**

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Aim to use recycled materials in any packaging where this is feasible, including:
  - Primary packaging
  - Secondary packaging
  - Tertiary packaging

## Criteria 4:

**Recoverability:**

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

- Investigate whether all of our packaging is recyclable at end-of-life and identify any gaps and opportunities for greater reuse or recycling.

## Criteria 5:

**Disposal Labelling:**

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

- As packaging is updated or refreshed, add on-pack information for consumers on recyclability or correct disposal.

## Criteria 6:

**On-site Waste:**

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Develop a system to collect and recycle used packaging generated at our facilities.

## Criteria 7:

**Problematic Materials:**

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Undertake the following to help reduce the impact of litter:
  - Conduct regular clean-ups on-site
  - Look for opportunities to redesign packaging to eliminate components that may have the propensity to become litter
  - Continue information & refresher training to ensure staff are fully aware of waste, bins and recycling options
